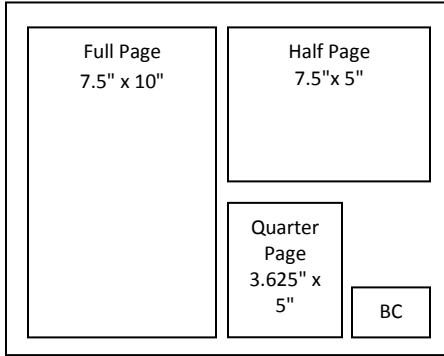

Les Passees, Inc. is a women's volunteer organization which provides advocacy and support to enhance the quality of life for children and their families in our community. Every fall, Les Passees operates Stock Exchange which is a "Consignment Shopping Mecca" featuring everything from kitchen wares to furniture and from collectible knick-knacks to fine jewelry and furs. The highly anticipated event lasts for six to eight weeks and attracts about 350 shoppers daily who come from all over the Mid-South to choose from items consigned from a database of over 4,600 participants. The Stock Exchange Magazine publicizes Stock Exchange, Les Passees' charities, and advertises local businesses.

Artwork Requirements: For BEST quality, logos should be submitted in vector format (EPS, PDF or Ai), however high resolution jpegs or tiffs are also acceptable. Pictures or additional graphics should also be high resolution JPEGS or TIFFS. Graphics and pictures that are downloaded from the web ARE NOT print quality and should not be submitted.

Acceptable file formats are PDF, JPG, TIFF and Ai (if fonts are outlined). If Microsoft Word files are submitted, Les Passees cannot be responsible for final ad quality. Although business cards may be submitted for a BC-sized ad, the quality of your ad will be better if it is also submitted digitally. Cards with pictures rarely reproduce well so the picture on any card should still be provided digitally.. Les Passees reserves the right to adjust the size of the graphics to fit.
